Bruce Evan Foster, age 72, of Midland, Texas, passed away on September 14, 2025. He was born on June 3, 1953, in Hobbs, New Mexico, to Vincent Duran Foster and Nelda Margaret Steffey Foster.

Bruce proudly served his country in the United States Air Force for six years, rising to the rank of Sergeant.

A gifted learner and a member of MENSA, he pursued higher education with great passion. He graduated from the University of Texas with a Bachelor of Business Administration in December 1976 and earned his Doctor of Jurisprudence degree in May 1978. Following his education, Bruce dedicated his career to serving others through the practice of law. He worked with the District Attorney's Office in Houston before entering private practice, where he tirelessly advocated for clients and frequently took on charitable cases to ensure justice for those most in need.

In the 1980s, Bruce settled in Midland, Texas, where he raised a beautiful family of five children.

Bruce was a man of many talents and passions. In his younger years, he was an avid flier, skier, and mountaineer. He loved photography, music, and computer science, and in later years became known among friends and family as a cat and coffee aficionado. Passionate about politics and justice, Bruce was guided by a strong sense of right and wrong and deeply committed to

truth and fairness.

He was preceded in death by his parents, Vincent and Nelda Foster; his sister, Karen Lynn Foster; his brother, Niles Reed Foster; his son, Joseph Alexander Foster; and his grandsons, Ethan John and Archer James Foster.

Bruce's memory will be cherished and carried forward by his children, Paul Foster, Jonathan Foster, Samantha Foster, and Anna Foster; his daughter-in-law, Tammy Foster; his grandchildren, Thomas, Daniel, and Juliet Foster; and his beloved cat and loyal companion, Swiper.
